The purpose of SAMHSA's Twitter use is to promote SAMHSA information, programs, policies, and strategic initiatives to the public. To provide a forum for two-way engagement between SAMHSA and the public in accordance with the Open Government Directive. To open or administer the SAMHSA Twitter, a SAMHSA Office of Communications employee/Direct Contractor enters the third party website SAMHSA username and password. This username and password information is saved on SAMHSA's internal/secure network and the only persons at SAMHSA who access and maintain SAMHSA'S Twitter are the staff of SAMHSA's Office of Communications/Direct Contractor. No SAMHSA employee/Direct Contractor PII is submitted to gain access.

The only information that will be collected is a person's Twitter username and the comment they posted that violated the commenting policy to stop serial abusers by blocking aliases.
