The Twitter account will be protected and all followers will be manually added to ensure they are OCIO employees. All protected Twitter accounts will not show up in a search engine, nor can they be retweeted to anyone who is not a follower of the protected account. Once people leave OCIO, it is part of the offboarding process to remove them as a Twitter follower. OCIO employees who wish to follow the protected Twitter account must email their twitter handle to TheMightyIT@hhs.gov from their HHS email address to ensure that all followers are OCIO employees.
