#### **CARB International Coordination Group**

- OGA/HHS, USDA, State Department
  - Participation from DoD, VA, DHS, OSTP, NSC, USAID, EPA, and HHS's CDC, FDA, NIH, CMS, AHRQ, BARDA, HRSA
  - Ensures coordination but also consistency
  - Ex: G7 Agricultural Ministerial
- PACCARB recommendations:
  - Fully embracing a One Health approach
  - Coordination of the federal response
