How the Conference Advanced the Mission of the Agency: This conference supported SAMHSA's strategic initiative on Trauma and Justice which provides a comprehensive public health approach to addressing trauma and establishing a trauma-informed approach in health, behavioral health, human services, and related systems, with the intent to reduce both the observable and less visible harmful effects of trauma and violence on children and youth, adults, families, and communities. Specifically, this conference is in line with objectives focused on coordinating and aligning SAMHSA's trauma technical assistance and training activities. This event allowed collaborative efforts by participants to share and exchange lessons learned, best practices, and innovations, and to develop resources on issues related to child trauma. Technical assistance was also provided in the areas of treatment and services, prevention, and sustainability strategies.

Presentations were given on strategic planning, crisis response, continuity of care, improving surveillance data, measuring program outcomes, interpreting data, advancing clinical workforce development, integrating alcohol and other drug use prevention activities with suicide prevention and mental health promotion activities, SAMHSA's Theory of Change (and how that relates to sustainability). This meeting directly supported Strategic Initiative #1, Prevention of Substance Abuse and Mental Illness, Goal 1.3: to prevent and reduce attempted suicides and deaths by suicide among populations at high risk.

How the Conference Advanced the Mission of the Agency: This event directly supported SAMHSA's Trauma and Justice Strategic Initiative by assisting selected states in addressing the behavioral health needs of adults, especially the disproportionality of adults of color, who are involved in the criminal justice system and struggle with transitioning and sustaining productive living in the community. It responded to specific action items of this strategic initiative by convening a reentry policy academy for states to develop policies that improve outcomes for these individuals. During this event, members of multi-jurisdictional teams worked together and with other states to identify and implement innovative approaches and strategies to support successful reentry of adults with co-occurring disorders from the criminal justice

system. The policy academy was preceded by consultation with participants on their overall goals and delivering written materials best suited to their interests and needs.

It also enabled the rollout of tools and the development of strategic plans to utilize financing policies and strategies in states and jurisdictions for diversion in order to increase the number of youth receiving behavioral health services and to successfully remain in the community and out of the juvenile justice system.

Topics addressed primary and behavioral health integration, electronic health records, clinical treatment services, information technology, prevention, financing and reimbursement strategies, recovery support models/systems, and military families. The agenda was aligned with SAMHSA's Strategic Initiatives on Prevention of Substance Abuse and Mental Illness, Health Care and Health Systems Integration, Trauma and Justice, Recovery Support, Health Information Technology, and Workforce Development. It was designed to respond to states' identified assistance needs and to encourage partnerships, policies, and programs that build resilience and facilitate recovery for people with or at risk for mental or substance use disorders. Discussions were also held on how to align and expand behavioral health care systems.

It also aligned program priorities to reduce the impact of substance abuse and mental illness by improving access to quality services and supports that enable individuals and families to thrive, participate in, and contribute to healthy communities. During this event, a technical assistance document was developed to guide states and communities in the design and implementation of the family-centered approach. This included strengthening the capacity to provide services across the continuum of care, including residential treatment.

SAMHSA Tribal College and University (TCU) Behavioral Health Summit

How the Conference Advanced the Mission of the Agency: SAMHSA has developed a tribal agenda, which clearly demonstrates SAMHSA's commitment to assist American Indians and Alaska Natives to access behavioral health systems that meet their needs. The tribal agenda also reflects a commitment to uphold the federal government's historical and unique legal relationship with tribes through consultation, outreach, education, and engagement. This event supported SAMHSA's mission by promoting and implementing prevention and early intervention strategies to reduce the impact of mental and substance use disorders in America's communities. The TCU Summit allowed attendees to develop an increased knowledge in the areas of trauma and justice related to American Indian and Alaska Native youth. It focused on the reduction of barriers for Native students to succeed, to help protect students, and to assist surrounding tribal communities through behavioral health awareness, education, and training. Perspectives of youth were used to develop the skills, tools, and support needed to be the generation for change in their communities. Topics included suicide prevention, substance abuse, bullying/school violence, LGBT, teen pregnancy, treatment, and long term recovery. Training was also offered in leadership programs, including question, persuade, and refer (QPR), mental health first aid (MHFA), applied suicide intervention skills training (ASIST), and pipeline.
