- suggestions as to what HHS can do to improve confidence in all recommended vaccines, and
- guidance on the utilization of evidence-informed best practice from a variety
 of research fields such as anthropology, psychology, and economics on how to
 successfully foster vaccine confidence through public, provider, and policy
 interventions."

The NVAC working group should:

- Recommend new and implementable strategies and approaches for sustaining and increasing confidence across the lifespan.
- Report findings for a vote during the September 2020 meeting.
