- Who is the appropriate audience?
- What is the best way to share the recommendation?
- What are the priorities of the Agency and bureau?



NACNEP 16th Annual Report to Congress Strategy:

Tips for making recommendations

Methods for providing recommendations:

- Congress
 - Annual reports
 - A-19 process
-
- Differentiate between a recommendation and a policy brief and/or white paper
 - Strong recommendations present a precise action that can be tied to a specific change that the Secretary or Congress can make
 - Become a member of the Writing Committee



BHW Priorities

- ▶ **Transform the health care workforce by creating training opportunities, incentives and sustained support for clinicians working in rural and underserved areas**
- ▶ **Increase access to behavioral health services, including SA disorder treatment**
- ▶ **Use health care workforce data to inform program and policy**
- ▶ **Infuse BHW values and priorities across the organization to guide decision making**
