

## Notice Regarding Recalculated 340B Ceiling Prices for Lilly Products

July 20, 2018

Eli Lilly and Company (Lilly) recently recalculated 340B ceiling prices for the following covered outpatient drugs during the following periods. Based on its wholesaler chargeback records, Lilly believes it can identify covered entities that may be eligible for recalculated prices and potential payment. Lilly will contact the covered entity's primary contact (listed in the HRSA database) and provide the relevant information. Lilly will request that affected covered entities compare Lilly's data with their own to validate the product eligibility and payment amounts and to work with Lilly on payment mechanics.

Lilly has asked the Office of Pharmacy Affairs (OPA) within HRSA to post this Notice on the HRSA public website to ensure transparency by providing access to information about Lilly's recalculation affecting certain 340B Covered Entities for the impacted Lilly product.
