I. Introduction

Dr. Joan Weiss, Designated Federal Official (DFO), welcomed Committee members and called the meeting to order. Dr. Carmen Morano, Chairperson, welcomed Committee members and discussed the expectations of committee members in developing the ACICBL 14th report.

II. New Member Orientation

Dr. Joan Weiss began the meeting with a presentation on the duties, roles, and responsibilities of the Committee. The main responsibility of the Committee is to provide advice and recommendations to the Secretary concerning policy and program development and other matters of significance concerning the activities under Title VII, Part D of the Public Health Service Act. She also discussed the role and responsibilities of the DFO, and the Committee Chair. She followed with a presentation on the programs under the purview of the ACICBL.

III. ACICBL 14th Report Discussion

The Committee discussed possible topics for the ACICBL 14th report. Many members discussed a desire to see a focus on the community health centers as training sites. Others suggested exploring how to use interdisciplinary teams to address access to healthcare. Some members suggested the report focus on geriatrics and care transitions. In addition, members proposed an emphasis on community mental health, healthcare disparities, and the use of technology to aid in access. The Committee Members suggested the following topics and issues to be the focus of the ACICBL 14th report:

- Geriatrics (Transitions of Care)
- Community Health Centers (Training, Culture of Health, Health promotion)
- Disease Focus (Dementia, Diabetes etc.)
- Patient Safety (Training in Quality Improvement)
- Multiple Chronic Conditions (Access and Interprofessional Care)
- Technology and Simulation in Preparation of Workforce
- Community Mental Health and Health Disparities in Rural Areas
- Paraprofessionals (Direct Care Workers, Community Health, Peer Training)
- Patient-Centered Care/Person Centered Care
- Emergency Preparedness (Models of IPE teams in Emergency Response)
- Promoting Community Living for Older Adults
- Improved Access to Care (Workforce Development for Programs)
- Podiatric Services

After further discussion, the Committee proposed the following report title and draft outline for the 14th report: Rethinking Complex Care: Preparing the Health Care Workforce to Foster Person-Centered Care.
