## **AHEC Program: Legislative Authority**

The Area Health Education Centers Program is authorized under Section 751 of the Public Health Service Act.







## **AHEC Program: Purpose & Eligibility**

#### • Program Purpose

• To develop and enhance education and training networks within communities, academic institutions, and community-based organizations.

### • Eligibility

 Public or nonprofit private accredited schools of allopathic medicine or osteopathic medicine, or a consortium of such schools. In states and territories in which no AHEC Program is in operation (or there is not an accredited school of medicine), an accredited school of nursing is eligible for funding.

- 48 AHEC Programs
  - 46 in Schools of Medicine
  - 2 in Schools of Nursing:
    - University of Alaska School of Nursing
    - Montana State University School of Nursing

- 261 AHEC Centers



## **AHEC Program: Provider Resilience Training**

- Award recipients will further develop behavioral health and paraprofessional training to address clinician burnout and improve provider resiliency.
- The centers will focus on innovative, evidence-based provider resiliency efforts to better address the needs of individuals with mental health and substance use disorders and prevent and mitigate burnout among health profession students, trainees, residents, and providers.
- AHEC grantees are currently addressing provider resiliency through continuing education activities, webinar series and resource pages to assist with individual clinician and health professions student's needs.
















