Meeting Objectives:

As an advisory body to the Secretary of Health and Human Services (HHS), and in accordance with its scope and charge “to inform and influence national and community-based policies and programs which impact infant and maternal mortality and related health outcomes of women, children, and families,” SACIM at its June 2021 virtual meeting will:

Objective 1: Finalize recommendations for submission to the HHS Secretary related to issues of current importance to pregnant and post-partum women, infants and children, and women of reproductive age concerning: COVID-19, the health of migrants on the southern U.S. border, environmental contributions to maternal and infant health, and workforce and clinical care systems.

Objective 2: Consider how current efforts to address racism as a determinant of infant and maternal health can be leveraged by SACIM in its work to address inequities in programs and policies and reduce disparities in maternal and infant health outcomes.

Objective 3: Increase SACIM’s understanding of the data issues related to maternal and infant mortality.

Objective 4: Identify the issues and activities that impact maternal and infant health that SACIM needs to focus on over the next year to most effectively execute the Committee’s charge.
